## 2021 BHC Dedicated Hunter Annual Report

The Border Hunting Club (affiliated to CHASA on SAPS Accreditation Registration Number 300018) empowered by Regulation 4 (1) - inter alia - the following:

"A hunting association that applies for accreditation must, in addition to the relevant information required by Regulation 2, submit proof to the satisfaction of the Registrar that (c) it has a dedicated procedure in place to regularly evaluate its dedicated members for their:

- (i) bona fides to be or remain a dedicated hunter and
- (ii) the dedicated participation in their applicable hunting activities.

(d) it keeps on record the particulars of their participation by dedicated members in their hunting activities as a dedicated hunter.

Therefore, the BHC, as an accredited association is obliged by law to require from dedicated members the submission of an Annual Dedicated Activities Report on an annual basis. **This report is thus a compulsory requirement and is essential to maintain the Dedicated Hunter Status.**

The BHC Hunting, Shooting and Club Activities Register makes provision for entries of relevant activities. Your signature and that of the committee member/range officer is a certified statement confirming your activities and serves as a Personal Log of your Dedicated Hunter Activities, which you in turn use to complete the **Summarised Annual Dedicated Activities Report - SADAR** (over the page).

The SADAR must be submitted annually to the club, such that we can verify your Dedicated Activities during the year, along with your membership fees for the coming year. If you have not been active, a "non-active" report must be provided to the BHC in order to maintain a Dedicated Hunter Status. **NOTE:** an unsuccessful hunt is still evidence of participation of a dedicated hunter!

### PLEASE NOTE

The Act has now been implemented fully; we need to get every Dedicated Hunter's **Summarised Annual Dedicated Activities Report (SADAR)**, in order for the BHC to keep you on their Dedicated Hunter's Register for submission to the Firearms Registry. The final cut-off for this is **31 October 2021**.
