

**CONDITIONS OF USE OF THE BORDER HUNTING CLUB**  
**SHOOTING RANGE AND USE AND**  
**POSSESSION OF SHOOTING RANGE KEY**

(hereinafter referred to as "BHC")

I, the undersigned

(as a paid up member of the BHC), acknowledge liability in favour of the BHC, upon certain terms and conditions :

I hereby acknowledge receipt of the keys which will grant me entry to the Border Hunting Club shooting facility at Mpongo Park, East London. I confirm that I will utilize the shooting range from \_\_\_\_\_ to \_\_\_\_\_ whereafter I will immediately return the keys to the responsible person. I agree not to hand the key to any third party and accept full responsibility for it. I agree that my entitlement to use the shooting range facility, limits me to inviting no more than three guests on any one occasion in the event that the guests will be utilizing the shooting range. In gaining entry to the range, together with my guests, I confirm that I will adhere to and follow all rules and regulations prescribed by the Border Hunting Club and/or any other law, rule or regulation pertaining to the use of shooting ranges, generally. I will be solely responsible for the key and will not hand it to any third party under any circumstance whatsoever.

In the event that I lose or destroy the keys or locks, I specifically acknowledge that, by my signature, I will be responsible for the full cost of the replacement of the necessary and existing locks and keys, presently an amount of R4 000.00 or the replacement cost as it changes from time to time. In the event that I lose or destroy the keys or locks I undertake, within 12 hours of this occurring to report the incident to the secretary of the BHC.

Upon signature hereof and as a deposit, I agree to payment of an amount of R200.00 which will be returned to me upon me returning the shooting range facility key to the person in charge as per the prescriptions of this acknowledgement and the rules of the BHC. The aforesaid deposit will be reduced by an amount of R50.00 per telephone call made to the depositor for each call made by the secretary to call for the return of the said key if the key is not returned prior to the return date.

Insofar that I suffer any damage or loss in any circumstance pertaining to my use of the Border Hunting Club shooting range either at the shooting range facility or at the Border Hunting Club premises, I accept the terms and conditions of the Deed of Indemnity per the annexure hereto and confirm having read same.
